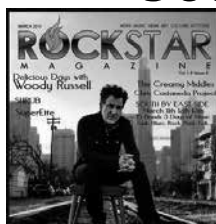

SRHOA BOARD OF DIRECTORS CORNER

Hello Neighbors,

By now the pool is open and you are probably already enjoying the warm weather. At least, I hope so. As of this writing the new pool white coat has been applied and the pool is filled with fresh, cold water. At the May 6 Board of Directors meeting we also approved repairs to the pool light mounting rings. After years of use and replacement of multiple layers of white coat, the light mountings were in need of replacement also. This should preclude seeing a pool light bobbing to the surface.

Also at the May Board meeting, we approved purchase and installation of the engineered wood fiber at two of the tot lots. You should see the improvements at tot lot #2 at Park Hill Lane and tot lot #12 at West Meadowland.

The May meeting also saw the Board write off a number of small delinquencies totaling all of \$39.03. These were a result of residents making errors in payments from a few cents to a few dollars. It makes little sense to show an account as delinquent for years for a few cents.

Let's take a moment to discuss violations. The office, and the Board of Directors has received a number of calls and emails from residents about their neighbors' covenant violations. We thank you for the heads up, most of these have already been identified during regular inspections, but there is always a chance that one has slipped by.

Once a violation has been identified, the owner is sent a First Notice letter identifying the violation and asking them to resolve the problem. All it takes to respond is a call or a visit to the office to let us know how and when the violation will be corrected. Residents have 14 days to respond to this First Notice. If there is no response, then a Final Notice letter is sent informing the resident that their violation is going to be referred to the Architectural Review Committee. The resident has 30 days to respond to the Final Notice.

If after the 30 day period has passed with no response, the owner will be notified that their violation will be reviewed by the Architectural Review Committee (ARC). The ARC meets on the second Tuesday of each month. The resident is encouraged to attend the meeting when their violation is being reviewed. Almost all violations are resolved before it escalates any further, but every now and then a violation will be referred to the Board of Directors to determine whether we will pursue legal action. The resident will receive a letter informing them that their violation is being considered by the Board. Again, the resident will be encouraged to attend the Board meeting.

Finally, as a last resort, the violation will be sent to our lawyers for legal action.

Notice, how nowhere in this chain of events is the neighbor who called in a complaint is notified of the disposition or outcome of their neighbors' violations. Each resident's account is their own personal business and not to be discussed with others.

Have a great summer, remember school's out so watch out for children, pedestrians and bicyclists in the streets.

APRIL 25 COMMUNITY TREE PLANTING SUCCESS

Thank you to the nearly 100 friends and neighbors who joined together to plant more than 100 trees in Sugarland Run. On April 25, trees native to Virginia were planted around Willow Lake and in the field behind Kale Avenue to provide wildlife habitat and reduce pollutants in our lake, creek, and ultimately the Chesapeake Bay.

This tree planting was made possible through a grant received by the Sugarland Run HOA by the Piedmont Environmental Council and the National Fish and Wildlife Foundation. All the plants and materials were provided through the grant. Additionally, Premier Landscaping contributed significantly to this project by pre-digging all the holes, installing an additional 30 shrubs, and donating all the mulch.



The 3-hour planting ended with a pizza party in the community center, followed by a guided nature walk. Many, many thanks to everyone who helped make this a great success!

Another tree planting is being planned for the fall, so be on the lookout for more information. - Give preference to plants native to this area www.wildflower.org/collections (click **Virginia**)
- Avoid plants known to be invasive www.vnps.org (click **Conservation > Invasive Plants in VA > Alien Invasive Landscape Plants**)
