WHAT'S HAPPENING

Private Property: The HOA Office has been notified that children have been kicking balls into the sides of houses/fences. While we all want children to be able to play ball with their friends, we also want our own private property respected. If you have school-age children, please ensure they know to respect other people's property while they are out playing.

Traffic Complaints: Loudoun County Sheriff's Office has an online form to report traffic complaints, including speeding and parking concerns. The form is located at https://lfportal.loudoun.gov/Forms/TrafficComplaint. Using the form helps establish a "paper trail" of the issue. Upon submission, you can receive a copy of the submitted complaint.

Home Security Inspection: Loudoun County Sheriff's Office provides home security assessments. These free surveys include a visual and physical inspection conducted by a deputy sheriff to evaluate your property from a crime prevention and security viewpoint. Based on the inspection, the deputy will make recommendations on how you can reduce your chances of becoming a victim of a crime by using proven crime prevention techniques. To schedule a survey, email Sheriffs Crime Prevention@loudoun.gov.

Yard Waste and Christmas Tree Disposal: Yard waste should either be retained on your property or properly transported to the landfill. Christmas trees can be dropped off for recycling at several nearby sites, including Claude Moore Park. Waste hauling companies often offer yard waste and Christmas tree services – if you have private trash service, please contact your waste hauler for more information. Do not use HOA commons areas to dispose of your yard waste or Christmas trees.

2023 Association Dues & Budget: The SRHOA & SRTHOA have approved the 2023 Budgets & Monthly Assessments. YOUR CURB APPEAL CHECKLIST

The curb appeal of our community depends on each resident maintaining his or her property as completely as possible. For those who keep their homes and yards well maintained, the association thanks you for your efforts and good examples. We encourage all residents to pay particular attention to the following maintenance items.

- Exterior paint. Paint is a quick and easy way to keep your property looking fresh, new, and clean. It will also protect against corrosion, weathering, and insects.
- Landscaping. Landscaping is extremely important to our community's curb appeal. Please remove dead plants and branches. Keep shrubs properly pruned and flowers well-tended. Keep yards free of leaves and remove grass clippings.
- Roofs. Please ensure your roofs are properly maintained and cleaned.
- Walkways. Please repair cracks, pitted or flaking surfaces, and other concrete problems. Remove weeds from walkway joints and debris from driveways and entrances. Do not use driveways for storage.
- **Gutters and downspouts.** Please keep them cleaned out to prevent overflowing and flooding.
