WHAT'S HAPPENING

Willow Lake: The work to restore the dam at Willow Lake (behind the Community Center) has been completed. This project was conducted in partnership with Loudoun County and is part of a two-phase plan to improve the water quality of the Sugarland Run stream, the Potomac River, and the Chesapeake Bay. The project has moved into the second and final phase, which will include draining the lake so that several feet of silt/sediment can be removed. Phase 2 will also include the planting of aquatic vegetation and recontouring areas around the lake to reduce erosion and improve stormwater management functions. Some of this work may begin later this year – the plans are still being finalized. The draft Phase 2 plan should be posted at www.srhoa.org by the time this newsletter is published. The HOA Board is working to ensure the changes not only improve water quality but also enhance the lake as an amenity for Sugarland Run residents.

Complaints/Concerns: Loudoun Express Request (LEX) is an online form to submit issues like speeding, loitering, damaged utility boxes, etc. to the Loudoun County government. These requests are tracked and are important to get problems fixed. Follow these steps to report a concern or complaint:

- 1. Go to Loudoun LEX at https://www.loudoun.gov/3055/Report-an-Issue
- 2. Click "Submit a request"
- 3. A new window will open
- Click on the appropriate category [such as "Utilities and Public Infrastructure" for utility boxes]
- 5. Click on the appropriate issue [such as "Cable and Broadband Service Requests" for utility boxes]
- 6. Fill in the requested information
- 7. Click "Submit"

Please remember that you live in a community that has mature woodlands with a variety of plants and wildlife among them. The natural appearing landscape around us is part of the charm of Sugarland Run. Setting off fireworks displays in your driveway; front or back yard is part of the celebration. When the caliber of



fireworks involves rockets, mortars, or something as simple as a Roman candle, the flying fireball/s can cause unforeseen damage to your or your neighbor's home as well as the habitat of native species we enjoy.

Be mindful of where your spent fireworks (rockets) land as they could cause fires or damage after their display is finished and they land with hot cores or coals. Even dry grasses or weeds could ignite and cause an issue. Some families may be traveling – unavailable to monitor their property.

As some lot owners have upgraded or maybe in the process of upgrading their homes with solar panels or additions, consider that debris from fireworks may contribute to wear and tear on the panels and that in-process additions or maintenance/repair work may be vulnerable.

A word about pets... please be sure to keep medication or other non-medicated solutions on hand for your animals that do not enjoy the fireworks.

POLICY RESOLUTION NO. 2023 - 001

Resale Certificate Fees

WHEREAS, pursuant to Section 55.1-2316 of the Resale Disclosure Act, community associations are required after July 1, 2023, to publish and make available a schedule of the applicable fees (i) for preparation and delivery of the resale certificate, updated resale certificate, and financial update; (ii) for the inspection of a property; and (iii) related to any post-closing costs; and

WHEREAS, it is the intent of the Board of Directors for Sugarland Run Homeowners' & Townhouses Owners Association ("Association") to exercise this power with respect to various services provided by its management agent in connection with the production of a resale certificate.

NOW, THEREFORE, BE IT RESOLVED THAT:

The following fees shall be levied to assist the Association in the defrayal of the costs incurred by the Association in the execution of the various aspects of the production of a resale certificate. The schedule of service fees is as follows:

Preparation and delivery in paper form	\$ <u>211.00</u>
Preparation and delivery in electronic form	\$ <u>176.00</u>
Inspection	\$ <u>141.00</u>
Additional Inspection	<u>\$141.00</u>
Resale certificate update	\$ <u>70.00</u>
Post-closing fee	\$ <u>70.00</u>
Rush fees	\$_70.00
