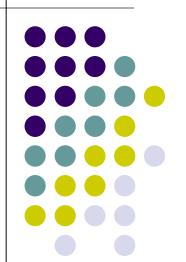

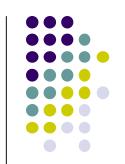

By continuing to survey residents, the Sugarland Run HOA board is able to track performance, measure progress in managing overall resident satisfaction, and establish investment priorities.



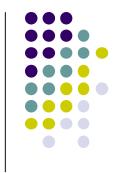
The 2017 data demonstrate important progress has been made, and illuminate some areas that merit attention.

Wave II Research: Good News



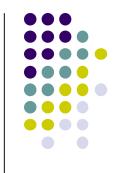
- The largest single group of respondents were aged 38 or younger. And, this age group was also larger than it was in the 2016 study. More engagement among young residents demonstrates community vitality
- Overall satisfaction with the performance of the HOA board improved Vs the Wave I survey, and the per cent who say they are "Very Satisfied" nearly tripled
 - In terms of transparency, residents overwhelmingly [81%] say they are aware of where and when Board meetings are taking place
 - There was a 2 pt increase in the per cent of respondents agreeing that they feel informed about the issues affecting the community, with nearly 70% saying they do.
- Based on 2017 verbatims residents are similar to the 2016 study in identifying these three tasks of the HOA board should focus on:
 - Maintain the community grounds and amenities
 - Maintain the community website
 - Maintain the newsletter

Wave II Research: Good News



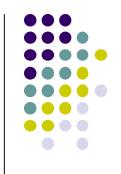
- Ratings of the management company on all three performance measures [responsiveness, accuracy, and courtesy] improved
 - The number of respondents saying they contacted the Association office in the prior
 12 months dropped significantly
 - Gains were especially noticeable in accuracy of information provided, and friendly/courteous treatment
- The newsletter continues to rank as the number one communications channel, with a large majority of residents saying they read it every month and nearly 60% saying the content is useful
 - The community Facebook page has quickly become a very important channel of information
- Overall satisfaction with Sugarland Run social events increased significantly. Despite competing local attractions, a signficant increase among residents interested in events for singles and couples.

Wave II Research: Good News



- An increase among residents using the community amenities a significant increase in the use of playgrounds, and slight increase in sports courts.
- Although Meeting Room usage is very low, there was a big increase in positive ratings on the rental policy, reservation process, and sign in process.
- Opinions of the swimming pool improved significantly, and on the measures of cleanliness and amenities /events, the number saying they were "Very satisfied", increased by 50% and 100% respectively
- Most residents say they are aware of the need for ARC approval and of the process for submitting modifications.



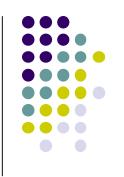


- The larger presence and more active role of younger residents could be influencing the use of, and interest in, different communication channels
 - The dramatic growth in the use of the SRHOA Facebook page, and use of enewsletter are emblematic of this
 - Their greater interest, participation and involvement suggests greater HOA use of digital communications
- The website seems to be playing an archival role a repository of "when/as needed information" rather than an interactive communication channel. It is not performing interactively
 - Considerable negative comments about design and functionality
- While most residents say they feel informed, those who don't continues to say it's because they don't know where to find HOA information

Wave II Research: Concerns

- Although the quantitative data point to improved Property
 Management staff performance, the verbatim comments suggest there is a continuing problem with issue resolution follow up on issues after they are reported or assigned
- While ratings of the swimming pool improved significantly on all measures, there was a noticeable drop in opinions on the playgrounds, trails, and a slight decline on ratings of overall grounds:
 - Trails ratings were significantly down vs 2016 on measures of maintenance and condition; slightly down on attractiveness
 - Playgrounds are showing a downward drift from satisfied to neutral suggesting overall decay in positive attitudes. Not negative, yet, but declining
 - Ratings for the overall appearance of common grounds, declined slightlynot as significantly as for the trails; it appears the influence of communities surrounding Sugarland Run may be having an impact





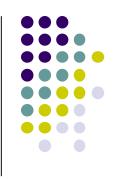
• While most residents say they are aware of the need for ARC approval and of the process for submitting *modifications*, verbatim comments suggest there are negative attitudes surrounding *compliance*.





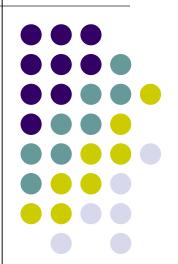
- Important strides have been made from the benchmark 2016 study to the Wave II survey.
- We are all media omnivores, and residents are no exception,. They use the HOA newsletter, Facebook page, and website in varying degrees for varying reasons. The board should define a role for each channel and design content accordingly [especially as the website is by accident or design an archival Vs interaction channel]
- The trails of Sugarland Run appear to be a key strength for residents, but they come in for criticism as opinions about their condition and maintenance mount.
- The data suggest action should be taken on improving the physical condition of the amenities
- And, while most residents say they would not want to serve on the Board, the majority give the current board high marks.



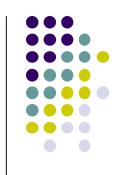


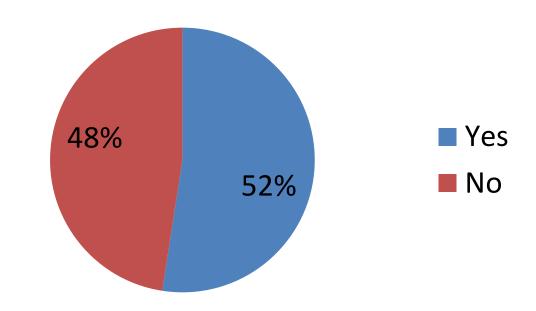

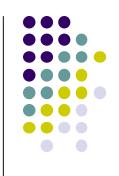


Have you contacted the association office in the past 12 months?

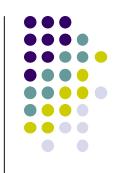
Do you feel informed about issues that affect Sugarland Run HOA?

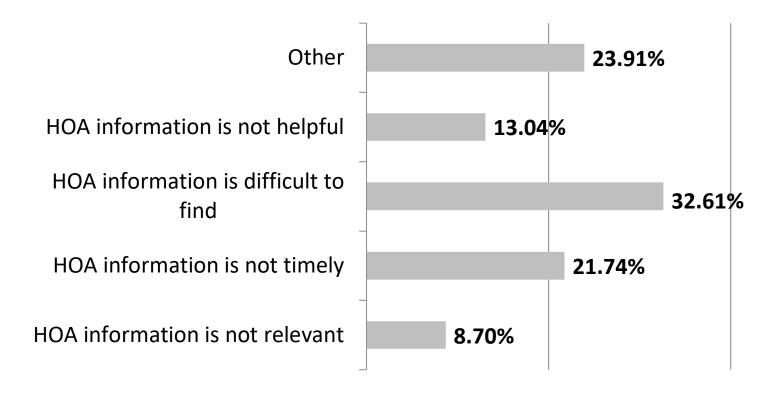

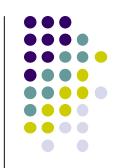


Other reasons for not feeling informed:

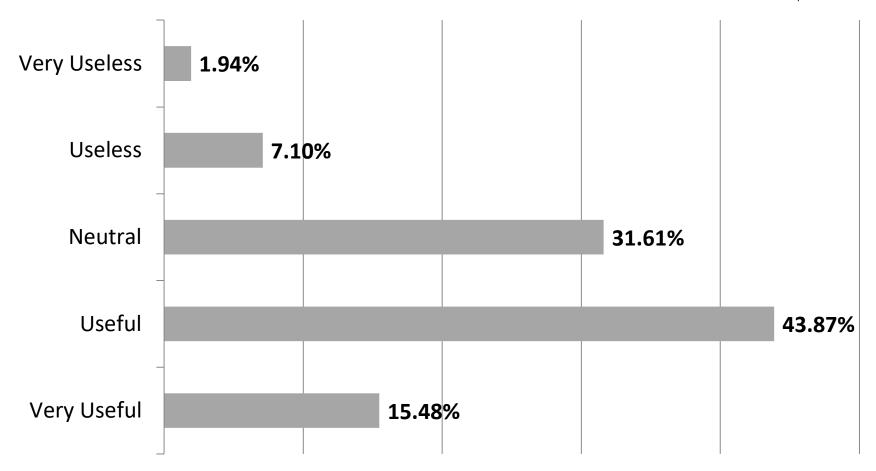
How often do you read the monthly newsletter?



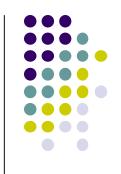


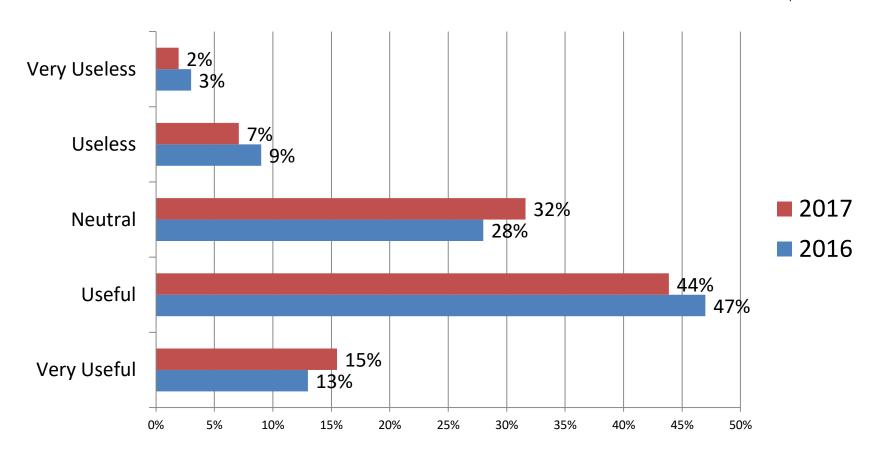

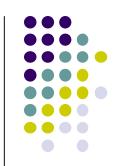
Are you satisfied with the quality of community social events that are held in Sugarland Run?





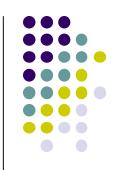

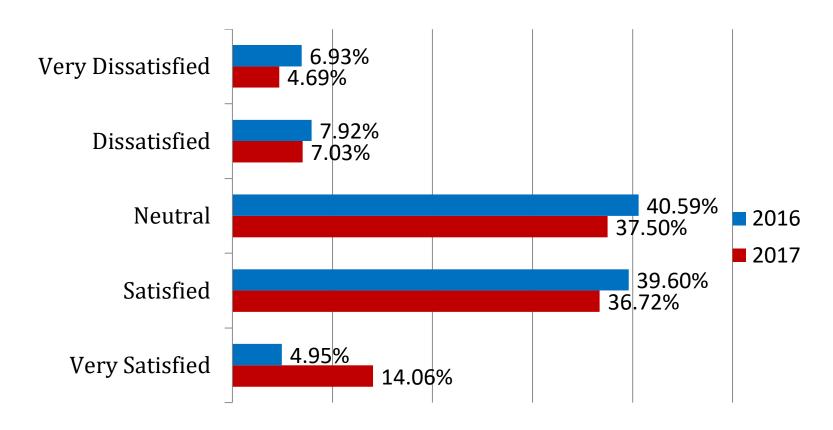
How satisfied are you, overall, with the performance of the HOA Board of Directors?



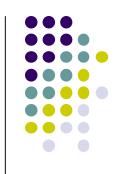


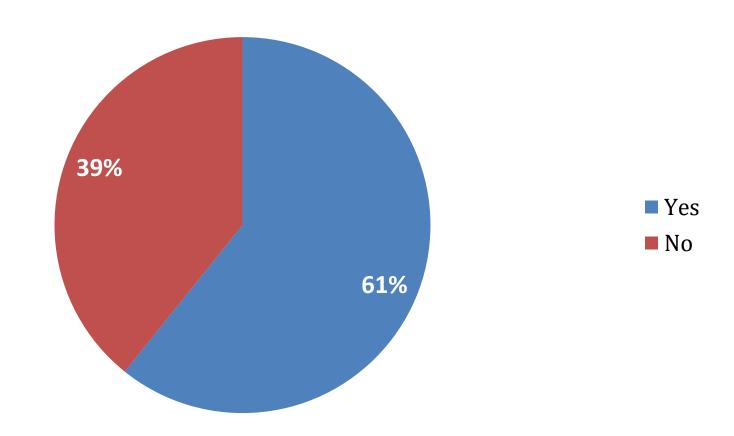

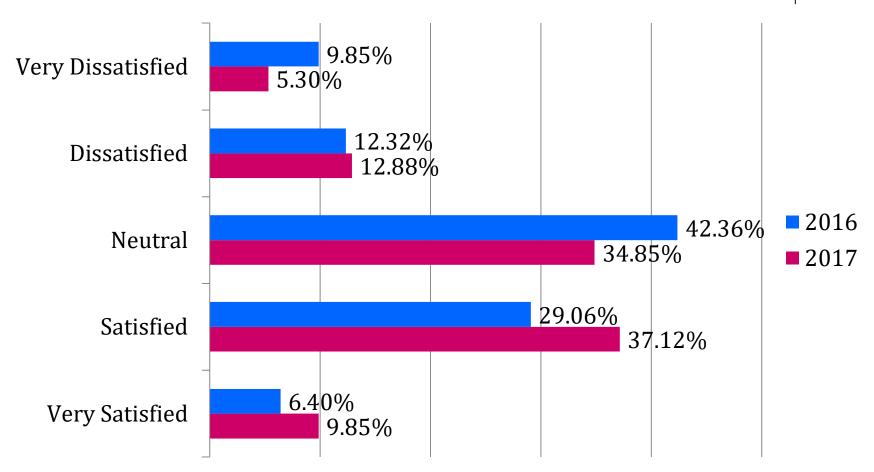
How satisfied are you, overall, with the performance of the Property Management Staff?

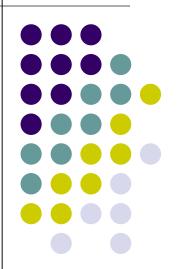

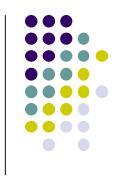

Comments about Property Management

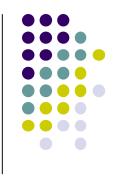






- I don't think I've ever seen one of them smile when I drop my dues off; it feels like you are a HUGE bother to ask for your pool pass,

- But having a e-service to accept HOA fees without charge is so adequated.





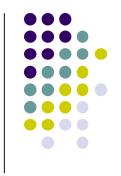
- I've had some great interactions and a couple of interactions that left me wondering. Overall positive.

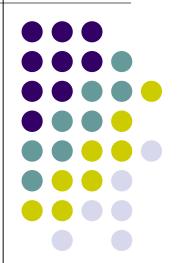
- people at the office are SO RUDE! Short, snappy, and not willing to help

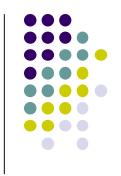

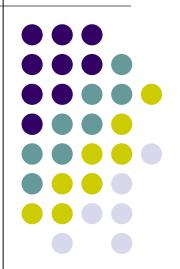
- See other comments No BOD minutes. The 'tone' needs to be more positive.

- used to be more in the newsletter seems they are cutting back on it



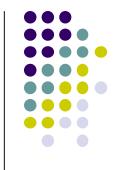

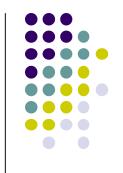




- nice trails but what's up with the cable wires running across the trails; broken cable boxes with guts hanging out and all the junk outside of TH fen.

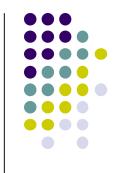






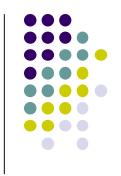
- We have a tot lot behind our house that my son uses and I would love to see updated equipment on it. It also needs new mulch and is often very weedy.

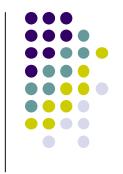


- Along trails, some brush and tree rubbish needs to be removed.

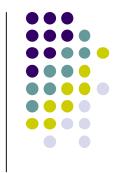






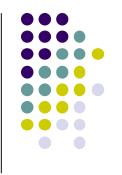

- Should be representing homeowners not likes and wants of board members. Grow with times or we will never make top place to live again





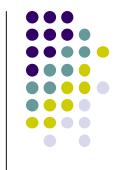

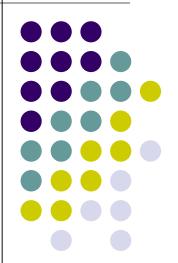
- Secretive, arbitrary

- What is being done about the crime? Little girl was molested on street. Paths and trees need repair. They are dangerous!



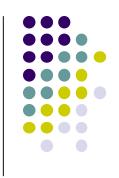


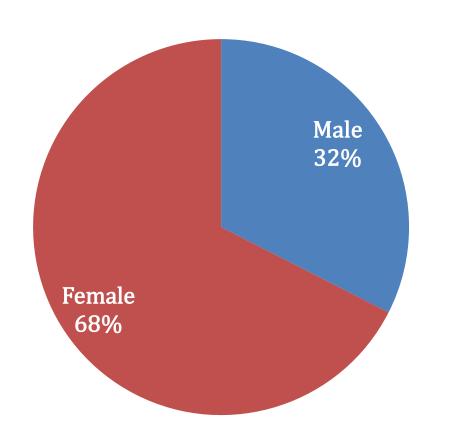

- Just want to say office staff has been delightful to work with thanks!



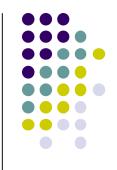
Respondent Demographics

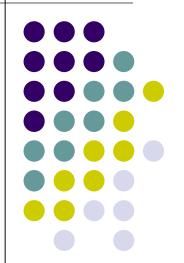
- •The questionnaire was developed in concert with the Sugarland Run HOA Board of Directors
