- Management submitted all the paper ballots on April 288, 2025, and received confirmation from HOA Vote now that the required guorum to hold the 2025 Annual Meeting has been met.
- Maintenance has walked and inspected the recent trail and concrete work performed by Fairfax Paving.
- Management and maintenance met with a fencing company to discuss the installation of a fence that would block access from 7/11 and Sugarland Square into the THOA property, and is looking into getting an estimate prior to the next meeting for this purpose.
- Management has inspected the areas where Premier Landscaping removed the approved trees and they have done a good job.
- Management has worked on the newsletter article for the THOA and had it in the May 2025 edition for the community.

David Mitchler MOTIONED to approve Fairfax Paving and Concrete, Inc. for additional concrete sidewalk replacement for a total of \$19,530. David Meier SECONDED the motion, and it <u>PASSED UNANIMOUSLY.</u>

Transfer of Funds: David Meier MOTIONED that the unappropriated equity of \$213,208.49, the board will be transferring \$113,208.49 into the reserve fund, leaving the unappropriated equity at a total of \$100,000. Kevin Leete SECONDED the motion, and it <u>PASSED UNANIMOUSLY.</u>
